

Exhibit Theme - Social Injustice

**On Display in Bob's Spot Gallery
October 2 - December 1, 2020**

Submission Requirements

- ♦ Open to artists residing in Arizona, 18 years and older.
- ♦ Two-dimensional artwork only.
- ♦ No entry may be smaller than a 18" x 18" or larger than 48" x 48" wall footprint (including frame) and weigh no more than 40 lbs.
- ♦ Do not submit work that has previously been exhibited in the Herberger Theater Gallery.
- ♦ Work must be available for exhibition and must be for sale. Once selected, no substitutions will be accepted. Artwork will remain on display for duration of exhibit.
- ♦ Pieces will not be accepted mounted on foam core alone.
- ♦ Work must be labeled on back with title and artist name.
- ♦ All artwork must be wired (plastic picture coated wire preferred) and ready to hang on a wire and hook system. Please put wire hangers (horizontally) on the back. Wire should be placed no more than 1/3 of the way down from the top of the frame and pulled taut.
- ♦ Work must not exceed \$3,000 per piece. The Herberger Theater receives a 30% donation from all artwork purchased. Consider this carefully when pricing work, as prices listed on application cannot be changed once selected. Artwork is insured for duration of exhibit.
- ♦ Work that does not follow these guidelines may be refused and returned to the artist.

Selection Process

Curators are Connie & A O Tucker. Work is selected using a blind jury process. Criteria to include: Adequacy to the Theme, Originality and Quality of Execution.

Theme Description

This exhibit will feature artwork relating to the current and past social injustices in our world. Social Injustice: A situation when unfair practices are done in society, such as discrimination.

How To Apply

There are **TWO** options to submit your application and images:

1) Submit electronically through WeTransfer.

2) Submit by mail on a flash drive or CD.

1) WeTransfer - submit up to six images, bio and artist information form

Go to WeTransfer.com and click on the plus sign (+) to add your files. Enter mbannon@herbergertheater.org, where it says "Email to." Input your email address if it doesn't autofill. Include the name of the exhibit in the message field, and then click Transfer. You will receive an email confirming that your transfer was sent.

2) Mail - submit up to six images, bio and artist information form on a Flash Drive or CD

Before uploading your images to WeTransfer, or saving them to a Flash Drive or CD please give each file a name as follows: Your Last Name 1-Title.jpg, Your Last Name 2-Title.jpg, etc. Each image must be 300dpi, minimum of 4"x6". Do not include artist name on the image of your work as this is a blind jury process. Save your bio and Artist Informaton Form as Your Last Name Bio and Your Last Name Info Form respectively.

Fee – \$25.00 non-refundable fee for up to six images. Pay online with your credit card.
